**A Chickamauga Memorial** - Timothy B. Smith 2009

A Chickamauga Memorial tells the full and fascinating story of how the country's first federally preserved national military park came into being and how it paved the way for all that came afterwards, including preservation efforts today. As Timothy B. Smith explains, most battlefield preservation and commemoration efforts before 1890 were done on a private and state level, with veterans' groups and states marking unit positions on battlefields, most notably at Gettysburg in Pennsylvania. In 1890, however, the federal government became involved on a large scale, ushering in a wave of battlefield preservation that would continue through the decades that followed. The brainchild of Henry Van Ness Boynton, a Union officer and veteran of the battle, Chickamauga

and Chattanooga National Military Park served multiple purposes as a commemorative memorial to the soldiers who had fought there as well as a military reservation for maneuver and study. As the former, Chickamauga played a prominent role in the reconciliation of the North and South, bringing together veterans from both sides. As the latter, the park played host to numerous military units during the Spanish American War as well as World Wars I and II. Perhaps the most important aspect, Smith contends, was the creation of historical memory in both. This process involved not only the historiography of the battles, but also how the battlefields themselves would be remembered, interpreted, and celebrated.

**The Golden Age of Battlefield Preservation** - Timothy B. Smith 2008

The 1890s, argues Timothy B. Smith in his new book, represented the climax of battlefield preservation in America. But what makes this decade so important? This decade was the perfect time for the establishment of these national parks. Five Civil War battlegrounds--at Gettysburg, Chickamauga and Chattanooga, Shiloh, Antietam, and Vicksburg--were commemorated as national sites during this time. Just past the bitterness and racial tensions of Reconstruction and prior to the explosive growth brought on by the Second Industrial Revolution, the time was right for the war's veterans from both sides to come together, in a spirit of reconciliation and brotherhood, to lead the efforts to open the parks. As yet unmarred by development, these battlefield sites were preserved mostly intact, just how the veterans would have remembered them. To date, they represent the country's finest preserved battlefields. Smith's book is the first to look at the process of battlefield preservation as a whole. He focuses on how each of these sites was established and the important individuals--the congressmen, the former soldiers, the veteran commissioners--who were the catalysts for the creation of these parks. **Grant's Victory** - Bruce L. Brager 2020-04-01

Two of the great themes of the Civil War are how Lincoln found his war-winning general in Ulysses Grant and how Grant finally defeated Lee. Grant's Victory intertwines these two threads in a grand narrative that shows how Grant made the difference in the war. At Eastern theater battlefields from Bull Run to Gettysburg, Union commanders—whom Lincoln replaced after virtually every major battle—had struggled to best Lee, either suffering embarrassing defeat or failing to follow up success. Meanwhile, in the West, Grant had been refining his art of war at places like Fort Donelson, Shiloh, Vicksburg, and Chattanooga, and in early 1864, Lincoln made him general-in-chief. Arriving in the East almost *deus ex machina*, and immediately recognizing what his predecessors never could, Grant pressed Lee in nearly continuous battle for the next eleven months—a series of battles and sieges that ended at Appomattox.

**The Chickamauga Campaign - Glory or the**

**Grave** - David A. Powell 2015-09-19

David Powell's *The Chickamauga Campaign*—*Glory or the Grave: The Breakthrough, Union Collapse, and the Retreat to Chattanooga, September 20-23, 1863* is the second volume in his magnificent projected three-volume study of this overlooked and largely misunderstood campaign. According to soldier rumor, Chickamauga in Cherokee meant "River of Death." The name lived up to that grim sobriquet in September 1863 when the Union Army of the Cumberland and Confederate Army of Tennessee waged a sprawling bloody combat along the banks of West Chickamauga Creek. This installment of Powell's tour-de-force depicts the final day of battle, when the Confederate army attacked and broke through the Union lines, triggering a massive rout, an incredible defensive stand atop Snodgrass Hill, and a confused retreat and pursuit into Chattanooga. Powell presents all of this with clarity and precision by weaving nearly 2,000 primary accounts with his own cogent analysis. The result is a rich and deep portrait of the fighting and command relationships on a scale never before attempted or accomplished. His upcoming third volume, *Analysis of a Barren Victory*, will conclude the set with careful insight into the fighting and its impact on the war, Powell's detailed research into the strengths and losses of the two armies, and an exhaustive bibliography. Powell's magnum opus, complete with original maps, photos, and illustrations, is the culmination of many years of research and study, coupled with a complete understanding of the battlefield's complex terrain system. For any student of the Civil War in general, or the Western Theater in particular, Powell's trilogy is a must-read.
